COVID-19 Services provided to our Students, Staff, and Community starting March 16, 2020 from Business Services Division (BSD) & Educational Service Division (ESD)

#### **STUDENTS - ESD UPDATES**

- We have provided a total of six weeks of Flexible Learning Options (FLO's) on our website as well as paper versions to ensure all students (and most vulnerable students) have resources to study at home prior to our Distance Learning Plan beginning.
- Three rounds of paper packet distributions that now take us to the end of the school year to supplement Distance Learning. To date, 7,769 students received ELA & Math packets.
- Distance Learning began on May 4th for all students.
- Site principals are monitoring and following up with students that have not been able to sign on to Distance Learning activities or have not been participating in online class activities.
- Our Mental Health/School Linked Services staff have provided telephone therapy to over 100 students so far.
- Planning 8th grade Virtual Promotion Ceremony with Middle School Staff. Virtual ceremony would be on either Thursday, June 11th or Friday, June 12th
- Summer Virtual Programs will be from June 18th July 15th. Virtual Programs will serve approximately 675 OGSD Students. Programs are: OGSD STEAM Academy, OGSD Extended School Year (ESY), SVEF Computer Science Institute (CSI), & SVEF Elevate Math
- ❖ Elementary School and Middle School Report Cards In collaboration with OGEA, our district has taken the guidance from the California Department of Education (CDE) as well as the Santa Clara County Office of Education (SCCOE) regarding grading during the COVID-19 pandemic. Most importantly, we are guided by principles of fairness, equity, and empathy. CDE has guided districts to ensure that this closure period "does no harm" to students regarding grades.
  - Our goal in collaboration with OGEA will be to assign all elementary students a No Mark (NM) grade for all areas of the standards-based report card, including citizenship and attendance. Middle School students will have a Pass / No Mark grade on their report card.
  - ➤ A "**No Mark" grade does not harm** a student's academic record. Following this guidance, students will receive feedback on work assigned and completed during distance learning. The focus of the feedback will be to help students make progress with learning the content standards, yet will not be formally graded. This ensures equitable practices for students who are unable to participate.

### **STUDENTS - BSD UPDATES**

- Completion of two rounds of Chromebook distributions. We successfully inventoried and signed out on loan 1,749 Chromebooks to our students. We have remaining inventory of Chromebooks and will continue to identify families that have not picked up a device.
- ❖ 1,000 Chromebooks will be distributed to Principals for their students at their sites based on need.

# COVID-19 OUR RESPONSE

#### **STAFF - BSD UPDATES**

- Google Voice accounts being provided to staff to outreach and communicate with all families.
- Chromebooks checked out to all secretaries as well as Google Voice so they can continue enrollment and program selection.
- ❖ 20,866 student instructional packets printed by the Print Shop
- All classrooms have been cleaned and sanitized.
- ❖ HVAC filters have been replaced at all sites, including the DO.

#### **STAFF - ESD UPDATES**

- Opened virtual OGSD University classes to our teachers to support distance learning.
- Our EdTech Team has been providing on-going professional development to all teachers on our Distance Learning District platforms.
- ❖ Teachers piloting a mobile and web based app *TalkingPoints* for multilingual family communication platform. Teacher sends the message in English and the family receives the message in their home language, then the family can respond in their home language and the teacher receives the message in English.

#### **COMMUNITY - ESD UPDATES**

- Starting May 11th our BASE program began Child Care for COVID-19 Essential Workers to serve up to 140 students. BASE Summer Camp will be from June 15th -July 31st.
- Community Liaisons called close to 4,000 low income families to make sure they have access to the internet, chromebooks, meals, groceries, food bank, and community services.
- Our community liaisons have connected with families to provide SLS Grant gift cards for groceries to 32 families so far.
- Connecting with 118 migrant families to provide district and community supports

### **COMMUNITY - BSD UPDATES**

- We have partnered with AT&T and will be getting 500 wifi hot spots for families, which will be provided to Principals tomorrow for distribution to their students.
- ❖ We provided more than 123,600 meals from March 16 to May 14.





#### **DISTRICT NURSE UPDATES**

## Communication

- ❖ Based on recommendations from SCCOE and Santa Clara County Public Health Department, we provide our families with a weekly update of new programs, services, and/or alerts related to COVID-19 (e.g. mental health resources, childcare for essential workers, local food programs, support for parents, virtual learning, community resources, etc.)
- ❖ Information is disseminated via District social media sites and ParentSquare
- COVID-19 Webpage on our District website with additional resources for families
- District Nurses are contacting families via email/telephone who were receiving direct nursing services - to provide check-ins, receive updates on health status changes, and plans for next year, etc.

# Medication Pick-up

- Coordinated a district-wide medication pick-up which concludes tomorrow, Friday
- Every parent/guardian, who had their child's medication on campus, was notified via telephone/email; a *ParentSquare* notification was sent out providing families the necessary information for medication pick-up and the process to follow to maintain social distancing
- Thank you health clerks for all your hard work, and principals for your support!

# **Updates on Health Clerks**

- ❖ We have been conducting bi-weekly virtual meetings with the health clerks
- Obtained Chromebooks for health clerks that needed access to work email and Infinite Campus
- Professional development; through various modalities, and with the support of Human Resources, Health Clerks have been remotely accessing online trainings for health conditions commonly seen in the school health rooms

# **Updates with SCC Nurses**

As District Nurses we are attending weekly meetings/webinars with at least one of the following organizations: Santa Clara County Nurse Coordinators, CSNO (California School Nurses' Organization), and NASN (National Association of School Nurses); likewise we stay current with the reports from Governor Newsom and SCC Public Health Officer

## **DISTRICT NURSE UPDATES (Continued)**

- We heard from EOC, at today's meeting, that they are working through new guidance on school reopening
- CSNO is currently working on a Health Services Recovery Plan, to come out later this month, with the intent to provide guidance to schools/districts surrounding special education health services, personal protective equipment, and general health services triage
- ❖ Most of the planning in these meetings is in regards to returning to school:
  - > Personal Protective Equipment (masks/gloves) and mass temperature checks
  - ➤ Return to school policies and procedures regarding students and staff excluded for presumed or diagnosed COVID-19
  - ➤ Immunizations/TB: currently requirements remain the same
  - ➤ Vision/Hearing Screenings: CSNO has submitted a formal request to the California Department of Education to waive mandated vision and hearing screening for the 2020-2021 school year
- We expect these decisions will be made at the state/county level and we will support and provide guidance to our district/community per policies and procedures dictated
